



Grants for Rain Gardens in the City of Falls Church



What? The Village Preservation and Improvement Society (VPIS) announces a new “RainSmart” program offering grants for design and installation of rain gardens and conservation landscapes in the City of Falls Church.

Why Rain Gardens? Rain gardens and conservation landscapes help manage stormwater, protect local streams and the Chesapeake Bay, reduce local flooding, and support watering of landscapes during dry periods.



How Much Grant Funding is Available? Grants are available to pay 50% of the cost of designing and installing a rain garden or a conservation landscape but will not exceed \$1,500 per project. There is a limit of one grant per applicant over a five year period. VPIS reserves the right to limit grant awards to the amount of funds available.

How Do I Apply? Complete the attached application and email it to VPIS at RainSmartFallsChurch@gmail.com or mail it to VPIS PO Box 6824, Falls Church, Va. 22040. VPIS will review and approve applications and send you an email approving funding for the project. You must be a resident of the City of Falls Church.

_____ I agree that the amount of my grant will be 50% of the final costs of designing and installing the project but will not exceed \$1,500.
